PUBLIC COMMENTS

Rudy Favila congratulated Mayor Leon on his reelection. He then expressed his concern that the City had not chosen to divide into voting districts. He also expressed concern with a recent police incident at Waba Grill suggesting racial motivations for the crime.

Peggi Hazlett provided an update on the Inland Empire Business Council and Chamber of Commerce accomplishments for 2018. She noted the annual holiday lunch tomorrow with installation of new officers and keynote speaker Tony Rose.

Karen Haughey, representing San Bernardino County Supervisor Curt Hagman, wished the Council a Merry Christmas and congratulated them on their reelection.

4. A RESOLUTION APPROVING AN IMPROVEMENT AGREEMENT, IMPROVEMENT SECURITY AND FINAL PARCEL MAP NO. 19643, LOCATED AT THE NORTHEAST CORNER OF CARPENTER AVENUE AND REMINGTON AVENUE

City Council adopted a resolution approving an improvement agreement, improvement security and Final Parcel Map No. 19643, located at the northeast corner of Carpenter Avenue and Remington Avenue.

RESOLUTION NO. 2018-165 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, APPROVING AN IMPROVEMENT AGREEMENT, IMPROVEMENT SECURITY AND FINAL PARCEL MAP NO. 19643, LOCATED AT THE NORTHEAST CORNER OF CARPENTER AVENUE AND REMINGTON AVENUE

5. A RESOLUTION PERTAINING TO DECLARED PRIMA FACIE SPEED LIMITS ON CERTAIN STREETS WITHIN THE CITY

City Council adopted a resolution rescinding Resolution 2017-098 and declaring prima facie speed limits on certain streets within the City.

RESOLUTION NO. 2018-166 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, RESCINDING RESOLUTION 2017-098 AND DECLARING PRIMA FACIE SPEED LIMITS ON CERTAIN STREETS WITHIN THE CITY.

6. COOPERATIVE AGREEMENT WITH THE CITY OF FONTANA FOR THE CONSTRUCTION OF IMPROVEMENTS AT THE INTERSECTION OF ETIWANDA AVENUE AND AIRPORT DRIVE/SLOVER AVENUE

City Council approved and authorized the City Manager to execute a Cooperative Agreement with the City of Fontana for the construction of improvements at the intersection of Etiwanda Avenue and Airport Drive/Slover Avenue.

7. COMPREHENSIVE ANNUAL FINANCIAL REPORT FOR FISCAL YEAR ENDED JUNE 30, 2018

City Council accepted the City of Ontario's Comprehensive Annual Financial Report (CAFR) for the fiscal year ending June 30, 2018.

8. A ZONE CHANGE (FILE NO. PZC18-002) TO ESTABLISH A ZONING DESIGNATION OF IG (GENERAL INDUSTRIAL) FOR 2.4 ACRES OF LAND LOCATED WITHIN NORTH LOOP DRIVE, GENERALLY WEST OF ETIWANDA AVENUE AND SOUTH OF THE INTERSTATE 10 FREEWAY

City Council considered and adopted a City-initiated ordinance approving File No. PZC18-002. Introduction and first reading of said Ordinance took place at a regular meeting of the City Council on December 4, 2018.

ORDINANCE NO. 3122 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, APPROVING FILE NO. PCZ18-002, A ZONE CHANGE TO ESTABLISH A ZONE OF IG (GENERAL INDUSTRIAL) ON A LOT TOTALING 2.4 ACRES OF LAND THAT CURRENTLY DOES NOT HAVE A ZONING DESIGNATION OR AN APN, TO BRING PROPERTY ZONING INTO CONSISTENCY WITH THE POLICY PLAN (GENERAL PLAN) LAND USE PLAN, AFFECTING PROPERTY LOCATED WITHIN NORTH LOOP DRIVE, GENERALLY WEST OF ETIWANDA AVENUE AND SOUTH OF THE INTERSTATE 10 FREEWAY, AND MAKING FINDINGS IN SUPPORT THEREOF—APN: N/A. (SEE ATTACHMENT A) (PART OF CYCLE 4 FOR THE 2018 CALENDAR YEAR).

9. CONSTRUCTION CONTRACT FOR THE POLICE PARKING LOT PROJECT/ONYX PAVING COMPANY, INC.

City Council awarded Construction Contract No. 1033 to Onyx Paving Company, Inc. of Anaheim California, for the Police Parking Lot Project in the amount of \$404,000 plus a 10% contingency (\$40,400) for a total amount of \$444,400; authorized the City Manager to execute said contract, authorized additional appropriations of \$100,775 from the General Fund, and authorized the filing of the notice of completion at the conclusion of all construction activities related to the project.

10. A PROFESSIONAL SERVICES AGREEMENT FOR PRESORTING AND MAILING SERVICES/INLAND PRESORT & MAILING SERVICES

City Council approved and authorized the City Manager to execute a one-year professional services agreement with Inland Presort & Mailing Services, of Redlands, California, with an estimated annual expenditure of \$275,000; and authorized the City Manager to extend the agreement for one additional year with the same terms and conditions.

MOTION UNANIMOUSLY CARRIED: Mayor Leon declared City Council Resolution Nos. 2018-165 and 2018-166, and Ordinance No. 3122 unanimously adopted.

11. A PUBLIC HEARING TO CONSIDER AN URGENCY ORDINANCE AMENDING SECTION 3-1.701 OF ARTICLE 7 OF CHAPTER 1 OF TITLE 3 OF THE ONTARIO MUNICIPAL CODE AND ADDING CHAPTER 31 TO TITLE 5 OF THE ONTARIO MUNICIPAL CODE, IMPOSING REGULATIONS ON SIDEWALK VENDING IN COMPLIANCE WITH SENATE BILL 946

City Council read by title only, waive further reading, and adopt an urgency ordinance amending Ontario Municipal Code Section 3-1.701 and adding Chapter 31 to Title 5 of the Ontario Municipal Code, imposing regulations upon sidewalk vending in compliance with Senate Bill 946.

Notice of public hearing was duly given and affidavits of compliance are on file in the Records Management Department.

There were no written communications.

Mayor Leon opened the public hearing asking those persons interested in this item to speak. Hearing no one, Mayor Leon closed the public hearing.

12. A PUBLIC HEARING TO CONSIDER RESOLUTIONS REGARDING THE FORMATION OF CITY OF ONTARIO COMMUNITY FACILITIES DISTRICT NO. 44 (ESPERANZA SERVICES); INTRODUCTION OF AN ORDINANCE LEVYING SPECIAL TAXES; AND DISSOLUTION OF CITY OF ONTARIO COMMUNITY FACILITIES DISTRICT NO. 11 (ESPERANZA I)

City Council:

- (A) Adopted a resolution establishing Community Facilities District No. 44 (Esperanza Services), authorizing the levy of special taxes within the community facilities district, and establishing an appropriations limit for the community facilities district;
- (B) Adopted a resolution calling a special election for City of Ontario Community Facilities District No. 44 (Esperanza Services);

- (D) Directed City staff to file a Notice of Exemption based upon the City Council's finding that the impacts for this existing facility is not a project and subject to environmental review and that there is no possibility that the activity in question may have a significant effect on the environment.

RESOLUTION NO. 2018-170 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, ACCEPTING THE ECONOMIC DEVELOPMENT SUBSIDY REPORT PREPARED PURSUANT TO GOVERNMENT CODE SECTION 53083 REGARDING THE DEVELOPMENT OF A REGIONAL SALES OFFICE BY CONCRETE HOLDING COMPANY OF CALIFORNIA, INC. IN THE CITY OF ONTARIO AND APPROVING AN OPERATING COVENANT AGREEMENT.

14. A RESOLUTION AUTHORIZING THE ISSUANCE OF SPECIAL TAX BONDS FOR COMMUNITY FACILITIES DISTRICT NO. 25 (PARK PLACE FACILITIES PHASE II)

City Council adopted a resolution authorizing the issuance of special tax bonds for Community Facilities District No. 25 (Park Place Facilities Phase II). The resolution:

- (A) Authorizes the issuance of special tax bonds for public improvements required to facilitate the development of the Park Place Facilities Phase II project;
- (B) Approves the forms of the Indenture of Trust, the Bond Purchase Agreement, the Continuing Disclosure Agreement, and the Preliminary Official Statement;
- (C) Authorizes a negotiated sale of the special tax bonds to Stifel, Nicolaus & Company, Incorporated (the "Underwriter") in accordance with the terms of the Bond Purchase Agreement; and
- (D) Authorizes the execution of the Indenture of Trust, the Bond Purchase Agreement, the Continuing Disclosure Agreement, and the Preliminary Official Statement by the City Manager, or his designee.

MOTION: Moved by Council Member Dorst-Porada, seconded by Council Member Bowman and carried by unanimous vote to adopt Resolution No. 2018-171.

RESOLUTION NO. 2018-171 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, AUTHORIZING THE ISSUANCE OF CITY OF ONTARIO COMMUNITY FACILITIES DISTRICT NO. 25 (PARK PLACE FACILITIES PHASE II) SPECIAL TAX BONDS, SERIES 2019, IN AN AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED \$10,000,000, AUTHORIZING THE EXECUTION AND DELIVERY OF AN INDENTURE, A BOND PURCHASE AGREEMENT AND A CONTINUING DISCLOSURE AGREEMENT, AUTHORIZING THE DISTRIBUTION OF AN OFFICIAL STATEMENT IN CONNECTION THEREWITH AND AUTHORIZING THE EXECUTION OF NECESSARY DOCUMENTS AND CERTIFICATES AND RELATED ACTIONS.

Mayor pro Tem Wapner commended Chief Elwell for his years of service to the City and encouraged him to enjoy his retirement. Wapner spoke about his re-election and thanked his wife Judi for her support and for always being there, noting that he would not be sitting where he was without her. He wished everyone a Merry Christmas and a Happy New Year.

Council Member Bowman commended Chief Elwell on his service to the City and wished him a great retirement. He thanked the community and Regina for their support during the election.

Council Member Valencia congratulated his fellow Council Members on their re-election. He thanked Chief Elwell for his service and congratulated Chief Gayk. He expressed pride about the charitable efforts of Police, Fire and the City family. He wished everyone a Merry Christmas.

Mayor Leon thanked his wife for her support over the last 36 years and noted that this was a tough election. He noted that public comments at the podium are not always correct and encouraged the public to hold speakers accountable for their comments. He wished all a Merry Christmas and Happy Hanukah.
