The Pledge of Allegiance was led by Council Member Dorst-Porada.

The Invocation was provided by Pastor Perez, representing The Salvation Army.

CLOSED SESSION REPORT

City Manager Ochoa reported that the City Council met in Closed Session for discussion of the above listed matter and provided direction to staff; however, there was no reportable action.

PUBLIC COMMENTS

Charles Ferrell, President of the Kiwanis Club of Ontario-Montclair, commented on the Club and upcoming events. He specifically noted the Pancake Breakfast and Car Show scheduled for June 1, 2019 in downtown.

Jeffrey Hackbarth, representing the Greater Ontario Business Council, thanked Mayor Leon for speaking at "Good Morning Ontario" and reminded Council and the community of the upcoming 59th Annual Police Recognition Luncheon to be held on May 14, 2019.

Joseph Nikyar expressed his concerns about increases in water rates. City Manager Ochoa referred Mr. Nikyar to Assistant City Manager Boling for an explanation of the City's utility billing and the proposed IEUA pass-thru rate increase.

Randi Campbell, representing Ontario Heritage, announced the Historic Home Tour scheduled for May 18, 2019 from 10:00 a.m.to 4:00 p.m.

Judi Wapner announced that May is Huntington's Disease Awareness Month. She detailed the symptoms of this fatal disease and encouraged efforts to raise awareness and find a cure.

Angelica Villagrana expressed concern with a situation that occurred at the new dog park at James Bryant Park. She explained that her puppy was attacked by a pit bull and ended up with a broken leg. She questioned why the pit bull had not been deemed vicious. City Manager Ochoa referred her to Police Chief Williams and Executive Director of Public Works Haes to address her concerns.

Benjamin Wood, a resident of Montclair, representing a group that holds polluters accountable, expressed concerns about the recent recycling facility fire. He questioned the toxins generated by the fire, the level of investigations completed and whether citations had been issued. He stressed the importance of ensuring compliance with City codes.

16. INTRODUCTION OF AN ORDINANCE AMENDING CHAPTERS 3, 7 AND 8B OF TITLE 6 OF THE ONTARIO MUNICIPAL CODE RELATING TO SEWER FEES AND INTEGRATED WASTE, SEWER AND WATER SERVICES

City Council conducted a public hearing to:

- (A) Consider all written protests against the proposed increases in the rates for sewer services in accordance with California Constitution, Article XIII D, Section 6(a); and
- (B) Introduce and waive further reading of an ordinance amending Chapter 3, of Title 6 of the Ontario Municipal Code related to integrated waste services; and
- (C) Introduce and waive further reading of an ordinance amending Chapter 7, of Title 6 of the Ontario Municipal Code related to sewer services and authorizing increases to the rates for sewer service charges and fees; and
- (D) Introduce and waive further reading of an ordinance amending Chapter 8B, of Title 6 of the Ontario Municipal Code relating to water services.

Notice of public hearing was duly given and affidavits of compliance are on file in the Records Management Department.

City Clerk Mautz advised that on March 22, 2019, 52,570 Prop 218 Notices were mailed to all Property Owners and Utility Customers and affidavits of compliance are on file in the Records Management Department. The City received a total of two valid written protests out of 43,786 Parcels and zero protests that do not meet the criteria to be counted. This does not constitute a majority.

Mayor Leon opened the public hearing asking those persons interested in this item to speak. He noted that the subject changes in sewer fees are a pass-thru from the Inland Empire Utilities Agency, or IEUA, as *their* elected board of directors had previously voted to approve this rate increase to support their capital improvement projects budget. He explained that it was being passed down to all IEUA's member water agencies, including the City of Ontario. He also noted that if the City of Ontario chose to absorb this rate increase into the City's budget, it would mean that Ontario's capital projects would go under-funded and fewer City projects could be completed. He indicated that for residents who would like to reach out to IEUA about their rate increase, staff has made their contact information available on the City's website.

Hearing no requests to speak, Mayor Leon closed the public hearing.

ORDINANCE NO. 3133 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, AUTHORIZING INCREASES TO THE RATES FOR ITS SEWER SERVICE CHARGES, MAKING CERTAIN REVISIONS TO THE ONTARIO MUNICIPAL CODE RELATING TO INTEGRATED WASTE MANAGEMENT, SEWER CHARGES, AND WATER FEES AND CHARGES, AND TAKING OTHER ACTIONS RELATED THERETO.

The City Council noted its moral opposition to this increase.

STAFF MATTERS

City Manager Ochoa had no comments.

COUNCIL MATTERS

Council Member Dorst-Porada reminded the community to take advantage of the May 18, 2019, Historic Home Tours.

Council Member Wapner thanked his wife, Judi Wapner, for speaking on the topic of Huntington's Disease. He stressed the need to raise public awareness, as there is no funding being designated to help find a cure for the disease. He indicated that there was some pending federal legislation for the Huntington's Disease Parity Act and encouraged people to ask their legislators for support.

Mayor Leon commented that the Cinco de Mayo event at Ontario Town Square was a success. He also noted that the event at De Anza Park also did well. He then addressed mosquito season and stressed that mosquitos carry diseases and kill many people each year. He encouraged residents to eliminate any standing water on their property.

Council Member Bowman had no comments.

Mayor pro Tem Valencia noted his blue light sitting on the dais in recognition of Police Memorial Week, and he encouraged attendance at the San Bernardino County Police Memorial event to be held on Thursday, May 9th at 10:00 a.m. at Ontario Town Square.

Mayor Leon invited D'Andre Lampkin to speak. Mr. Lampkin announced that his foundation will be working with the City to plant trees at Veteran's Memorial Park from 8:00 a.m. to noon on June 1, 2019. The foundation will be providing lunch and snacks for the 100 volunteers they hope to have participate.

ADJOURNMENT

Mayor Leon noted the cancellation of the May 21, 2019 meetings and adjourned the meetings of the Joint Agencies at 7:58 p.m. to the next regular meetings to be held on Tuesday, June 4, 2019.
