CLOSED SESSION REPORT

City Attorney Duran reported that the two matters of litigation were discussed, as listed on the agenda. With regard to the first, the City Council received a briefing. With regard to the Ohio Casualty Insurance matter, the City Council received a briefing, provided direction to staff; and there was no reportable action on either case.

PUBLIC COMMENTS

Yvonne Ross, expressed ongoing concerns caused by a local homeless person. She explained that he has committed several varied misdemeanors and as inquired about the availability of services to assist the homeless in our community.

Brant Devey, Team Captain for the Ontario Police Department Baker to Vegas Team, detailed the Baker to Vegas event and the City's 17 years of participation. He spoke on the team's efforts which resulted in a first-place finish in their division and an overall 15th place standing in this year's event.

Joe Estrada, Ontario Police Department, discussed the Runners Scholarships that stemmed from the Baker to Vegas efforts. He reported that last year the team gave out two \$800 scholarships to Chaffey High School students, and this year they were awarding two \$1,000 scholarships. He presented them to Arlene Rios and Adrian Rios both from Chaffey High School. He also presented the City Council with first place mugs from the Baker to Vegas race.

D'Andre Lampkin, of the Lampkin Foundation, thanked the residents and sponsors who participated with the Foundation in the tree planting event at held recently at Veteran's Park. He stressed that the event demonstrated what can be done when people come together for a common mission.

Karen Haughey, representing County Supervisor Curt Hagman, invited the City Council and the community to a paper shredding event on June 15, 2019 from 9:00 a.m. to noon in the Ontario Police Department parking lot. The public may bring up to five file boxes of paper per car. She further explained that the event's intent is to help in preventing and bring awareness to identity theft, and she encouraged residents' participation.

16. A LEGAL SERVICES AGREEMENT FOR INTERIM CITY ATTORNEY SERVICES

City Council considered a Legal Services Agreement with Cole Huber LLP, of Roseville, California, to provide City Attorney services on an interim basis, and authorized the City Manager to execute said agreement.

Council Member Dorst-Porada expressed concern that the recommended firm might not have the experience and expertise to meet the City's needs. She expressed her preference that the City should have allowed for a more extensive bid and proposal process, and indicated that she would be voting "no" on this item.

Council Member Wapner asked about the term of the agreement. City Manager Ochoa clarified that the agreement would proceed through the balance of the calendar year, and after the New Year there would be an evaluation of whether to make the arrangement permanent or engage in a solicitation and selection process. Council Member Wapner thanked Best Best & Krieger for their service as City Attorney, noting he was on the City Council when they were first hired. He stated that they have done an incredible job representing the City, but expressed his position that when you have a contract for 23 years it does not hurt to investigate what else is out there in the marketplace. He stressed that there was nothing detrimental about Best Best & Krieger, and they do a good job representing other clients that he is on the board of.

Mayor Leon indicated that he was in alignment with Council Member Dorst-Porada's comments, and noted that he was not dissatisfied with Best, Best & Krieger. He also noted that he had no negative issues with Cole Huber. He stressed that the decision of the City Council would be observed by the team as we move forward.

MOTION: Moved by Council Member Bowman, seconded by Council Member Wapner and carried by a vote of 3 to 2 with Council Member Dorst-Porada and Mayor Leon casting the dissenting votes to approve the Legal Services Agreement with Cole Huber LLP, of Roseville, California to provide City Attorney services on an interim basis.

STAFF MATTERS

City Manager Ochoa had no comments.

COUNCIL MATTERS

APPOINTMENT TO THE PLANNING COMMISSION

Mayor Leon discussed the process for filling Board and Commission vacancies and explained that there was currently a vacancy on the Planning Commission due to the untimely death of Richard Delman. He explained the importance of development experience on this particular commission and stressed the significance of the Planning Commission to the community. He recommended former Planning Commissioner Nick Ricci to fill the vacancy.

MOTION: Moved by Council Member Wapner, seconded by Council Member Dorst-Porada and carried by unanimous vote to appoint Nick Ricci to fill the current vacant position on the Planning Commission (term to end with the certification of the November 2022 election).

Mr. Ricci commented on the sad circumstances leading to this appointment and noted that Mr. Delman had served as a mentor to him. He thanked the City Council for their confidence in allowing him to serve and that he would do his best to honor Mr. Delman's legacy.

Mayor Leon commented that Mr. Delman is irreplaceable, but Mr. Ricci brings his own qualifications and will do a spectacular job.

Council Member Dorst-Porada expressed appreciation for Mr. Ricci's ongoing commitment to the community and participation with area service clubs.

Council Member Wapner commended Mr. Ricci on his service in the U.S. Navy.

Council Member Bowman welcomed Mr. Ricci back to the Commission.

Mayor pro Tem Valencia thanked Mr. Ricci for his service to the Country.

Mayor pro Tem Valencia thanked D'Andre Lampkin for coordinating volunteers for the tree planting event, noting they did a great job. He also commended the Police Department staff for their participation in the torch run for Special Olympics.

Council Member Bowman congratulated the Police on the Baker to Vegas Run.

Council Member Wapner noted that the remains of WWII Staff Sergeant Vincent Rogers had been returned to his family and honored recently. He thanked his family for his service and thanked the multiple honor guards who participated in the transfer.

Council Member Dorst-Porada noted the June 6, 2019 organizational meeting for National Night Out. She noted all the events over the past weekend such as the tree planting, the Rotary Car Show and Kiwanis Pancake Breakfast; and reminded everyone of the July 4th festivities. Noting that the signs for the world's largest picnic are in need of refurbishing, she asked for the community's help. Council Member Bowman explained that the signs represented each of the fifty states, and residents who had ties to those states would sit in those sections of the picnic tables along Euclid Avenue on July 4th.

Mayor Leon thanked the airport for their assistance with the return of serviceman Vincent Rogers' remains. He also noted it being mosquito season and reminded everyone to remove areas of standing water. He addressed the issue of homelessness and agreed that it is a real concern, but also multi-faceted. He noted the City Council's commitment to help and encouraged people to come forward and identify concerns as the City Council cannot see everything in a City the size of Ontario. He also encouraged use of the MyOntario smartphone app to report issues such as potholes, debris, trash, etc.

ADJOURNMENT

Mayor Leon adjourned the meetings of the Joint Agencies at 7:29 p.m. to the next regular meetings to be held on Tuesday, June 18, 2019.
