MINUTES JUNE 6, 2017

JOINT MEETINGS

Regular meetings of the Ontario City Council and Ontario Housing Authority were held on Tuesday, June 6, 2017 at the Ontario City Hall, 303 East B Street, Ontario, California.

CLOSED SESSION

Mayor Leon called the City Council and Housing Authority meetings to order at 6:01 p.m., and inquired whether persons were present who wished to speak to the Closed Session item. Hearing no one, the City Council with all members except Council Member Wapner present recessed to Closed Session at 6:02 p.m. for discussion of the following:

CALL TO ORDER - OPEN SESSION

Mayor Leon called the City Council and Housing Authority meetings to order at 6:30 p.m., and requested the City Clerk call the roll.

Also present were City Manager/Executive Director AI C. Boling, City Attorney/Legal Counsel John Brown and City Clerk/Secretary Sheila Mautz.

REPORT ON CLOSED SESSION

City Attorney Brown reported that the Council did confer and give direction to the Labor Negotiator as listed on the agenda.

The Pledge of Allegiance was led by Council Member Bowman.

Pastor Dan Davis, Truth and Grace Ministries provided the Invocation.

PUBLIC COMMENTS

Tom Burciaga paid homage and recognized Richard Hernandez who died recently, noting that he was a great steward for the City. He stressed Mr. Hernandez had a heart for the community and its residents, and Burciaga provided details on Hernandez' funeral service and burial. He thanked Mayor pro Tem Dorst-Porada and Code Enforcement staff for addressing an issue at his church on Good Friday. He also noted the remembrance of D-Day, and recognized Jimmy Flores, a City resident who is a D-Day and WWII survivor.

Karen Haughey, representing Supervisor Curt Hagman's office, announced a Workforce Development Department Job Fair on June 22, 2017 from 9:00 a.m. to 1:00 p.m. at the National Orange Show – Renaissance Room in San Bernardino. She invited residents to participate.

Ryan Baccas, CEO of the Cannabis Coalition, encouraged the City Council to consider lifting the ban on the commercial marijuana market in Ontario, suggesting that it would help to eliminate the black market for marijuana. He noted efforts he has led in other communities, detailed his background and offered to assist the City in writing new policies.

Andres Ramirez, representing the San Bernardino County Transportation Authority, discussed the West Valley Connector Project. He detailed the project and its benefits, and noted upcoming open house meetings relating to the environmental studies. He announced the Montclair/Ontario meeting is on June 13, 2017 from 3:00 to 7:00 p.m. at the Ontario Senior Center. He provided flyers and noted that more information could be obtained from their website at gosbcta.com.

Robbin Delgado commented on her love for living in Ontario, but noted an issue at the theater on C and Euclid. She indicated that the theater was the site of a huge event on Friday night with people were throwing beer bottles, smoking marijuana and taking all available parking. She further stated that there was urinating in public and a lot of cussing. When she contacted the police, she was told that there was security inside the building, but she was concerned with the approximately 200 people outside in the parking lot. She asked that the Council observe an event at this facility and give it the proper attention. Mayor Leon asked that the City Manager meet with Ms. Delgado to address her concerns.

Chrissy asked the Council to consider allowing the sale of medical marijuana, noting that she is fighting lupus and is required to go to San Bernardino to get her medical marijuana. She expressed concern with her neighbors growing their own due to the lack of regulation and requested that the Council give this matter consideration.

24. CONSIDERATION OF A RESOLUTION OPPOSING MEASURE "H" IN THE CITY OF CHINO

The City Clerk reported one phone call received by the City Clerk's Office from *Deb Hilak*, 1613 Magnolia, in support of the proposed proposition.

City Council held a public hearing to consider adoption of a resolution opposing Measure "H" in the City of Chino.

Judy Briggs thanked the City Council for their past support of the efforts of "REAL Ontario", and encouraged support of this resolution. She expressed appreciation to the Council for trying to do what is best for the residents and make them feel protected and secure. She indicated that they would welcome development at this location, but it would have to fit the neighborhood, possible with half acre lots. She noted that the residents on Benson Avenue have safety concerns, but there are other problems with the proposed development plan and expressed hopes that the Chino City Council would support residents over profits. She thanked the Ontario City Council for following up and putting this item on the agenda.

Catherine Borne, resident of Ontario and property owner for 30 years, noted that she too is a member of REAL Ontario. She expressed elation that Ontario listened to concerns and allowed residents to keep their rural lifestyle. She indicated that she lives on Benson Avenue and she is now experiencing anger, frustration and fear over the proposed development across the street in Chino. She indicated that the developer would be paying for street improvements, but she does not want the street widened or a traffic signal to be installed on the street. She has been told that increased traffic is inevitable, but suggested that it is only inevitable if housing density is increased. She requested Council support and adopt the proposed resolution.

Mayor Leon inquired of City Attorney Brown with regard to Council Member Valencia's ability to participate in this discussion, due to the proximity of his home to the proposed development. City Attorney Brown indicated that he reviewed the distance from the proposed development and Valencia's property; and in addition to the Council's individual freedom of speech right on matter such as this, he did not believe that there was a nexus to trigger a financial effect so in his opinion there was no disqualification required.

Barry Borne, resident on Benson Avenue, member of REAL Ontario and Protect Chino, indicated that he was opposed to the proposed project due to increased noise, traffic and safety concerns. He stressed that the project would bring 180 homes in an area zoned for 30 homes, and is surrounded by half-acre horse property. He further stressed that the Chino Planning Commission opposed the project and the Chino Mayor opposed the project; and a group of residents is knocking on doors to educate the public.

Matt Evans, owner of the property subject to the Measure H Election, commented on the similarity of this hearing to those in Chino. He suggested that if Ontario had an issue with the project they should have communicated it well before today. He stated his belief that this hearing was intended to influence the special election in Chino, even though the project was outside Ontario's jurisdiction. He questioned the appropriateness and purpose of the hearing. He also questioned if it was fair for a Council Member to bring this matter forward to the Council to decide on behalf of the City.

City Manager Boling clarified the early statement by the City Clerk, noting that the caller (Deb Halik) was in support of the "resolution" being considered, not the "proposition", and that the record should reflect that.

Mayor Leon took exception to the comments by Mr. Evans, and provided clarification on behalf of the City. He indicated that Council Member Valencia did not bring this matter forward, the residents did. He indicated that it is timely because they brought it to the City at the last Council meeting. He concurred that it was out of jurisdiction, but noted that Chino has approached Ontario on its issues. He commented that he has let Chino's representatives know that he is not in support of this project. He also stressed that this is not a seamless border society, and what impacts one community impacts another; and good relationships between communities benefit everyone.

Council Member Wapner concurred with the Mayor that the precedent had been set by Chino, and indicated that a Council can bring up matters whenever they wish to protect the residents. He indicated that the City does generally enjoy a good relationship with neighboring cities and this is not taking action on what is happening in Chino, but voicing an opinion in support of our residents.

Council Member Bowman indicated that he was all in on supporting the resolution, as it was the right thing to do.

Mayor pro Tem Dorst-Porada indicated that the residents and the Council have worked hard to maintain the rural lifestyle for these Ontario residents and she would like Chino to do the same. She noted that they have a beautiful park in the area and she is hoping this resolution will save the rural lifestyle.

Council Member Valencia confirmed that he lives near the affected area and noted that as a horse owner, his daughters go to Briggs Park all the time. He indicated that their biggest complaint is the speeding vehicles, and there is currently a house on Benson that is up for sale for the same reason. He suggested that with the addition of 180 homes it will be an even bigger issue. He expressed support for the residents and the Council's proposed action.

Mayor Leon thanked everyone who came forward and participated in this hearing.

Mayor pro Tem Dorst-Porada thanked the residents for coming out and staff for all of their hard work. She noted the upcoming July 4th festivities.

Council Member Wapner had no comments.

Mayor Leon noted the weekly concerts in the park and advised that this meeting would be adjourned in memory of Richard Hernandez.

Council Member Bowman had no comments.

Council Member Valencia commented on the Memorial Day event at Bellevue Cemetery, noting that it was a great event to pay homage to those who have served in the armed forces. He noted the concerts in the park, with last Wednesday being a Selena cover band. He indicated that staff is doing a great job bringing great acts to the City. He also noted that there are movie nights at Ontario Town Square on Friday nights. He commended Kiwanis on their pancake breakfast and Rotary car show and encouraged the public to enjoy all of the events that Ontario has to offer.

Mayor Leon noted that in May the City Council (Leon, Dorst-Porada, Wapner and Valencia) attended the International Conference of Shopping Centers in Las Vegas, with a great display and a lot being accomplished.

ADJOURNMENT

Mayor Leon adjourned the meetings of the Joint Agencies at 7:15 p.m. in memory of Ontario resident Richard Hernandez and announced the next regular meetings on Tuesday, June 20, 2017.
