Between 10 – 25 acres	\$905.5
Greater than 25 acres	\$2,074
NPDES (WQMP) Review:	\$1,145
MISCELLANEOUS FEES	
Legal Review:	Hourly Rate (check with Engineering Front Counter)
Misc./Special Technical Report Review:	Varies (actual cost plus 25% admin for consultant review, if applicable)
Overtime Pay for Inspection: (weekends & holidays)	Hourly Rate (check with Engineering Front Counter)
Storm Water Pollution Abatement:	Varies (monthly BAU fee based on land use type and site acreage – applied to utility bill)
Water Meter:	See Water Meter Application for Meter Fees (based on meter size)
