- IX. New Business: ARG Presentation, Master Facilities Plan
 The presentation covered the following goals and aspects of the Master Facilities Plan
 now being developed into final form:
 - The Master Facilities Plan covers a 20-year outlook.
 - Strengthen visitor experience and value to the community.
 - Clarify gallery organization and circulation.
 - · Optimize curatorial and administrative spaces.

- Provide dedicated space for educational programs.
- Preserve historical features of the former City Hall building.
- Meet code and accessibility standards for historic structures.
- Upgrade building systems.
- Position OMHA to receive AAM accreditation.
- ARG also noted that rather than taking a systems-wide approach, instead the South Wing gallery space for the new "Built, on Water" exhibit could serve as a pilot model for renovating the space to meet museum standards and historic preservation standards.

Feedback after the presentation was positive. Board President Chris Kueng and City Council Liaison Dorst-Porada both requested that costs associated with the Facilities Master Plan be prepared in time for the plan to be considered for final presentation to the Board of Trustees and the City Council, in time before City budget discussions begin in March 2019 for the upcoming fiscal year.

City Council Liaison Dorst-Porada requested board and staff feedback on why the work enumerated in the Master Facilities Plan is an important funding priority. Museum Director Worden outlined the following points:

- The Master Facilities Plan ensures that the Museum is able to fulfill its stewardship of the community's artistic, cultural, and historic legacy. Capital improvements are crucial for the Museum to receive accreditation, making the museum better able to attract grant and community funding support.
- The Museum is a historic gem, worth preserving as it gives character to and is a defining feature of Ontario.
- The Museum has spent the last five years increasing its exhibits, programs, and outreach activities, adding to its value to community residents and visitors.
- The Museum is a linchpin at the heart of the growing arts and culture district. The district is not just a location it is a range of collaborative activities that anchors and activates historic Euclid Avenue and downtown.
- Together, these historic and cultural elements become defining characteristics of what sets Ontario apart from neighboring communities and makes Ontario an attractive place to live, work, and visit.
