AGENDA REPORT SUMMARY

For the past two and a half years the Museum has been working on meeting the criteria to be eligible to apply for Accreditation with the American Alliance of Museum. One requirement in order to receive Accreditation is that the Museum is open to the public 1000 hours per year. A survey was conducted over the last two months to determine the best schedule for extending hours, and Thursdays from 4-8pm was found to be ideal. Staff will share plans for rolling out information about the new hours to the community.
