- 4. Approval of Minutes

- 6. City Council Liaison Everyone is doing the best that they can. The City of Ontario is a retail center and is feeling the affects of the Governor's 6-month extension for business owners to pay their retail and sales tax. There is a \$34 million short fall, but the city will be ok with that amount and will use its reserves and other options. Waiting for safety measures to be put in place so that City Hall can open to the public soon. Just received notice that barbershops and hair salons can reopen with modifications.

J. Worden presented a summary of the three breakout groups and explained what was meant by digital environment. This includes a virtual platform, social media, website, online programs, etc. Things that the Museum are currently doing include social media posts, e-newsletter, Covid-19 Chronicles, Arts & Culture website, and the CLC virtual Website. There are concerns on the amount of time and funds are needed for increasing the Museum's virtual content and staff availability. Having more of a virtual presence has always been a goal of the Museum and the current pandemic has accelerated the need regarding the need for virtual content. The Agency are now seeing what resources they have available to create content. The Museum will be looking to see what grants are available to help with cost, also looking into exploring different types of partnerships as a way to help with cost. Discussion took place on what the Museum could do, what City resources and outside resources are available, and ideas on different content and what can the Board do to help. The consensus of the group is that it would be nice if the Museum was able to have a standalone website that allows for a better visitor experience. The staff will reach out to the Communications and IT departments to see what assistance they can provide.

• Will be asking for input on the Museum Associates case statement. The Museum store has thought of putting items online in the past and after looking at a museum store site, thinking about showcasing one item to sell online. Asked Board to brainstorm on what one item the store could sell that best represents the Museum.
