- 4. Approval of Minutes
 - Minutes of September 22, 2020 were approved on a motion by Randy del Turco and seconded by Ada Lopez.
- 5. Public Comment None
- 6. City Council Liaison The winds caused damage throughout the City, thankfully no one was hurt. It will take weeks to get everything cleaned up. Thankfully the Nativity scenes were not up yet, and Council Member Dorst Porada has talked to Public Works about better securing them. Starbucks is going up and the Bank of Italy project is still in the works. The project on the corner of D & Euclid will get started in a couple of months.

 Museum will remain closed to the public for the foreseeable future. California
 Association of Museums (CAM) has sent a letter to the Governor that states while
 malls are open during this time, museums are not, and it seems to be an unequal
 application of criteria.

Each section of the new policy was reviewed, and the Collections team answered any questions the Board had including questions on the deaccession process and providing online content to the public. The next steps were covered: the adoption of the Disaster Plan and Institutional Code of Ethics, submitting core documents for verifications and applying for accreditation. Board members had a lot of positive feedback, felt it was a very thorough document.
 - Board decided to vote for adoption at tonight's meeting.
 Collections Management Policy was approved for adoption on a motion by Rick Caughman and seconded by Randy del Turco.

The policy doesn't need to go to the City Council, but Councilmember Dorst-Porada would like to bring it up at a Council meeting to let the rest of the Council know what the Museum has done and acknowledge all the hard work.
