CITY COUNCIL LIAISON DORST-PORADA

Council Member Dorst-Porada shared that the City of Ontario just passed the budget for the new Fiscal Year and development updates and discussed the status of developments throughout the City.

STAFF REPORTS

Introduction

Executive Director Helen McAlary provided an introduction of the new Curator of Education, Miriam Valle-Mancilla to the board. Miriam provided a brief bio and background of her career in Museums.

Directors Report

Executive Director McAlary advised on the museum's updated operating hours and the latest COVID-19 regulations for visitors. She provided and update on the ADA restroom that is being added at the front of the museum, collections move update, and a Built On Water Exhibit update. She shared that the museum store employee, Irene Gapido, will be retiring on June 30, and the Museum and Museum Associates will be working together to reimagine the operations of the museum store. Conversation ensued between the group regarding the store's revenue, impacts on accreditation, merchandise content, and the potential for the board members to visit surrounding museum stores for suggestions. Executive Director McAlary shared of two endowments and trusts that are specific to the Museum: the Denton Endowment and the Barnes Trust. Additionally, the Ontario Motor Speedway Fund, which can be used for community programs and events. The Denton Endowment and the Ontario Motor Speedway Fund will be utilized for museum projects. Conversation ensued regarding the need to strategize how to best utilize these funds over time. Executive Director McAlary discussed the City of Ontario's recently adopted budget for the new fiscal year, which included new allocations to the Museum and concluded with the suggestion to take a caravan tour to share the Council Member and Board Member's favorite places to Cindy and Miriam. Executive Director received a request for an update on the recruitment for Museum Director which she then provided.

Collections Move to Bon View Storage Site

Michelle Sifuentes shared a presentation providing an update on the move, including number of items moved, the staff who are assisting, and the process for the packaging and storage of the items. Questions were asked by the board and City Council Liaison which Michelle provided answers.

Built on Water Questionnaire

Leslie Matamoros provided background information on the purpose of the questionnaire and shared the questionnaire with the group, challenging them to reach 50 quotes from the public, which will be used in the exhibit.
