- B. MILLS ACT CONTRACT REVIEW FOR FILE NO. PHP24-003: A public hearing to consider a Mills Act Contract (Preservation Agreement) for a 1,980 square foot Victorian style single-family residence, a Contributor to the Villa Historic District, located at 314 West H Street, within the MDR-11 (Medium Density Residential-5.1 to 11.0 du/ac) zoning district. The Contract is not considered a project pursuant to Section 21065 of the CEQA Guidelines. (APN: 1048-262-25) submitted by Kali Rose Heitholt and Christopher Ordaz. City Council actions are required.
- C. MILLS ACT CONTRACT REVIEW FOR FILE NO. PHP24-008: A public hearing to consider a Mills Act Contract (Preservation Agreement) for a 1,408 square foot Craftsman Bungalow style single-family residence, a Contributor to the El Morado Court District, located at 208 East El Morado Court, within the LDR-5 (Low Density Residential-2.1 to 5.0 du/ac) zoning district. The Contract is not considered a project pursuant to Section 21065 of the CEQA Guidelines. (APN: 1048-243-02) submitted by Daniel Gillis. City Council actions are required.
