В. **ENVIRONMENTAL** ASSESSMENT, **PLANNED** RESIDENTIAL DEVELOPMENT, TENTATIVE TRACT MAP AND DEVELOPMENT PLAN REVIEW FOR FILE NOS. PRD14-001, PMTT14-008 AND PDEV14-016: A request for certain entitlements for 6.11 acres of land located at 2041 East 4<sup>th</sup> Street to include: 1) A Planned Residential Development to develop the site as one land use complex and establish development standards that depart from the base zone (R1.5 Low-Medium Density Residential) allowing for reduced lot sizes, lot coverages and setbacks; 2) A Tentative Tract Map (TT 18984) to subdivide the site into 55 numbered lots and 2 lettered lots; and 3) A Development Plan for the construction of 55 single family detached homes, private/common open space areas and recreational amenities. The proposed project is located within the Airport Influence Area of Ontario International Airport (ONT) and was evaluated and found to be consistent with the policies and criteria of the Airport Land Use Compatibility Plan (ALUCP) for ONT. environmental impacts of this project were previously analyzed in a Mitigated Negative Declaration (MND) prepared for the related applications File Nos.
