Installation of Banners along Median of Milliken Avenue

The following Conditions of Approval have been placed on your approved sign program for the installation of 9 double sided banners along street lights on the center median of Milliken Avenue, between Fourth Street and I-10. Should you have any questions please call Luis Batres at 909 395-2431.

### **Planning**

Any damage caused by the installation, placement or removal of the banners and related hardware to any City property (street lights, poles, streets, curbs, landscaping, irrigation systems etc) is to be corrected in a timely manner to the City's satisfaction at the sole expense of the permit applicant.

### **Engineering**

With respect to performance of work under the Permit, the applicant shall maintain and shall require its subcontractors, if any, to maintain Commercial General Liability Insurance, or equivalent form, with a combined single limit of not less than \$1,000,000 per occurrence. Such insurance containing a aggregate shall (1) include additional insured endorsement naming the City of Ontario, its officers, agents, representatives, employees, and volunteer as additional insured; 2) be primary with respect to insurance or self-insurance program maintained by the City of Ontario 3) contain standard separation of insured provisions; 4) give the City of Ontario prompt and timely notice of any claim made or suit instituted arising out of the applicant's operation hereunder. The applicant shall a) furnish properly executed certificate of insurance and additional insured endorsements to the city of Ontario prior to commencement of work under this Permit, which shall clearly evidence all coverges required above, provided that such insurance shall not materially changed or terminated except on 30 days prior written notice to the City of Ontario b) maintain such insurance from time work first commences until completion of the work under this permit; and c) replace such certificates for policies expiring prior to completion of work under this Permit

The applicant shall save, keep and hold harmless the City of Ontario, its officers or agents from all damages, costs or expenses in law or equity that may at any time arise or be set up because of damage to property, or of personal injury received by reason of or in the course of performing work authorized by this permit which may be occasioned by any act or omission of the applicant, his agents or employees. The City will be not be liable for any accident, loss or damage to the work prior to it completion and acceptance.


Distance from pole base to bottom of banner shall not exceed 12 feet.

Banner must be removed prior to June 23, 2010.



A durable 13oz vinyl sleeve between the pole and the WindBreaker hardware provides protection from scratches.








### WindBreaker Bracket System
