Checks shall be submitted to the Planning Department and shall be made payable to the "Clerk of the Board." The required fees are as follows:

Notice of Exemption Filing Fee	\$50.00
Notice of Determination Filing Fee	\$50.00
Filing of a Negative Declaration / Mitigated Negative Declaration (includes Notice of Determination filing fee)	\$3,018.75
Filing of an Environmental Impact Report (includes Notice of Determination filing fee)	\$4,173.50

<u>Notes</u>:

- (1) "T & M" means fees will be charged on a time and materials basis. An initial deposit will be collected at the time of application submittal. Any unused deposit amount will be returned to the applicant following final action on the application.
- (2) "*" means a 5% General Plan Fee is included in the total fee. The General Plan Fee covers the cost of updating, maintaining, and implementing the City's General Plan in compliance with State law.
- (3) "** " means a public hearing or review fee is also required, in addition to the application fee(s), as required by the Review Matrix (Table 2.02-1) in Chapter 2 of the Development Code.
