#### RESOLUTION NO. 96-26

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ONTARIO, CALIFORNIA, APPROVING AN AMENDMENT TO THE SHEA BUSINESS CENTER SPECIFIC PLAN

WHEREAS, the Planning Commission of the City of Ontario held a public hearing on February 27, 1996, to review a proposed amendment to the Shea Business Center Specific Plan; and

WHEREAS, this amendment would add property to the Specific Plan area, relocate Shea Center Drive further north adjacent to the I-10 Freeway, delete medical offices and certain conditional uses, and allow distribution facilities; and

WHEREAS, the Planning Commission recommended City Council approval of a Negative Declaration which was prepared to address the environmental issues of the project; and

WHEREAS, the Specific Plan Amendment must comply with the conditions of approval recommended by the Planning Commission and Development Advisory Board.

NOW, THEREFORE, BE IT RESOLVED that Specific Plan Amendment 4873-SPA is hereby approved.
