All other normal programming has either been transitioned to virtual programming or on hold until the facilities reopen again.



AGENDA REPORT SUMMARY

The Recreation & Community Services Department is pleased to announce the promotion of three staff members to Recreation & Community Services Coordinator positions.

- **Samantha Ochoa:** A resident of Ontario, Sam has a passion for serving others and providing community members with resources to broaden their futures. Sam first started with the City of Ontario as a Instructor/Guard in 2013 and rose through the ranks to become a Pool Manager in 2019 and most recently an Office Assistant. Sam has been a key member working with the contract class instructors and has also worked with our marketing team. In her new role as Coordinator, Sam will take over as the lead in

overseeing contract classes and will also take over the Ontario on the Go program. Sam holds a B.A. in Sociology and Anthropology from the University of Redlands and an M.A. in Public Anthropology from American University in Washington, D.C. We will be backfilling Sam's previous Part-Time Office Assistant position in the near future.

- **Joey Lemus:** If you know Joey, you know the positive attitude and upbeat energy he brings to the Recreation team. Joey first started with the City of Ontario in 2017 as a Senior Recreation Leader at the Dorothy A. Quesada Community Center. He then transitioned to an Office Assistant position at the Armstrong Community Center overseeing administrative and clerical functions. Joey also has experience working for the City of Fontana and City of Rancho Cucamonga Recreation Departments and exudes passion in working with teams, serving the community, and mentoring staff. Joey is currently finishing school at Chaffey Community College. Over the next couple of months, Joey will transition to the Ontario Senior Center to program senior center activities and develop the active older adult program citywide. We will be backfilling Joey's previous Part-Time Office Assistant position in the near future.
- **Jordan Wilson:** A passionate public servant and dedicated team member, Jordan has also accepted his promotion to Coordinator for the Recreation Department. Jordan first started working for the City of Ontario in 2007 as a Senior Recreation Leader at the Ontario Senior Center. Jordan was then promoted to an Office Specialist position at the De Anza Community & Teen Center in 2014 and recently came to the Armstrong Community Center when we restructured the Department last Summer. Most recently, Jordan has been serving in an Acting Coordinator role to take on more duties and responsibilities for the Department. For now, Jordan will stay at the Armstrong Community Center overseeing fields and facility reservations and will then transition with the Anthony Munoz Community Center team when that facility opens later this year. The Department has decided to delete Jordan's previous Office Specialist position to create this new Coordinator position.
